More Fake News??

In response to the article entitled 'Town Loses Market to Rival Town' in this week's edition of The Looker, it is claimed that the Town Council did not respond to emails requesting discussions about the possibility of a weekly market on St. Martin's Field. It is further claimed that the company that runs the market approached the Town Council directly in regard to this possibility.

Fact: NO enquiry from a company that runs a weekly market has been received by the Town Council.

Fact: An informal enquiry was received from Mr Wimble about a potential market as follows:

The Town Clerk then, having returned from leave, provided the following explanation:

Dear Mr Wimble,

Thank you for your enquiry.

I can confirm that St. Martin's Field, whilst owned by the Town Council, its day to day running is administered by a separate charity - St. Martin's Field Charity - and that its Trustees are serving Members of New Romney Town Council who remain as Trustees for the duration of their Term of Office. Having been previously a Town Councillor, I am sure that you will be aware that St. Martin's Field Charity meetings are not public meetings and are not required to be.

As is evident, the response regarding ownership of St. Martin's Field was provided in regard to a completely separate enquiry from Mr Wimble and not in regard to his informal enquiry about a market – as is intimated in the afore-mentioned article - for which he was provided with an immediate response which, in turn, supplied him with all the necessary information to assist him or any third party market operator in submitting a formal application for use of St. Martin's Field.

It is of note that no formal application for use of St. Martin's Field has subsequently been received, either from Mr Wimble or any third party market operator.
